EXHIBITION REGULATIONS
Desoto Arts Council Visual Arts Committee

In order to assure a positive, equitable experience for all participating artists the following regulations will be used for any visual arts exhibition. All deadlines and specific requirements must be strictly followed. **Exhibition prospectus and exhibition regulations must be present at time of entry, signed and dated by artist.**

MEMBERSHIP: Membership in DeSoto Arts Council (hereafter referred to as DAC) must be current.

ORIGINAL WORK: Artwork must be of the artist's own original concept and execution. Classroom work (where using someone else's artwork for reference), copies of paintings and copies of published photographs will not be accepted. Paintings done from photographs **MUST** have permission from the photographer.

IDENTIFICATION: Each piece submitted for a show must **have a 3x5-inch index card, attached securely to the back, listing the artist's name, address, phone number, title of work, media, dimensions and the price.** .

DELIVERY/PICK UP: The artist must agree to deliver and pick up his or her artwork during the stated time frame. **No late entries will be accepted.** All work must remain in place until the end of the show. It must be promptly signed for and picked up during the release time period. DAC must be notified if someone other than the artist will be picking up artwork. **Any artwork left over 30 days past the pick up date will become property of the Desoto Arts Council.**

ACCEPTANCE: Work must be dry and properly prepared for exhibition (paintings framed). **Frames must be wired for hanging. No saw tooth hangers will be accepted. (This is to assure the protection of your work and the professional appearance of the gallery.)** Unframed, gallery wrap (1 1/2" min) is accepted but sides must be painted. Artist must provide stand for three-dimensional work. Because of space limitations, large items will have to be evaluated as hanging occurs. All jewelry must be displayed under glass and easily opened. The acceptance of work in any show is conditional on availability of exhibition space, suitability of work and compliance with the rules here established for the DAC. If a juried show, the decision of the juror(s) is final.

PLACEMENT: The hanging of a show is the responsibility of the Visual Arts Committee. Moving or re-hanging of a piece once the committee has completed hanging the show is not permitted. Artist may replace a sold piece or relinquish the space to another artist.

SALES: Artwork will be available immediately upon purchase. Purchasers may take possession upon payment or artists may arrange delivery if requested by purchaser. All payments will be made to Desoto Arts Council. DAC will retain 20% commission on all sales of art displayed in this show (10% for volunteers with 24 hrs of svc in current calendar quarter). DAC agrees to make artist payments by the 10th of the following month.

The DeSoto Arts Council shall not be responsible for lost or damaged art work in connection with any exhibition. Gift shop items must be accompanied by an inventory list with item numbering system.
